EXTREME FIRE HAZARD TRAVEL AND ACTIVITY RESTRICTIONS

WHEREAS, the Board of Chelan County Commissioners are authorized, based on the recommendation of the Fire Advisory Board, to officially determine and announce when any area or County road shall be designated as a fire hazard area, taking into account the need to prevent occurrence of fires which might be caused by recreational, residential, commercial, industrial and other activities; and,

WHEREAS, on August 1, 2018, the Fire Advisory Board Chairman, based on the current and forecasted conditions recommended designation of a fire hazard area and implementation of **Extreme** travel and activity restrictions; and,

WHEREAS, the next regular meeting of the Board of Chelan County Commissioners is scheduled for August 6, 2018 and therefore will not occur within the next twenty-four hours; and.

WHEREAS, pursuant to Chelan County Code Section 7.52.020(3), the Chelan County Fire Marshal may temporarily designate a fire hazard area and impose travel and/or activity restrictions in the event the Board of Chelan County Commissioners are unable to meet within twenty-four hours after the fire advisory board transmits its recommendation:

NOW, THEREFORE, pursuant to 7.52.020(3) the Chelan County Fire Marshal hereby temporarily designates all unincorporated areas of Chelan County to be a fire hazard area and that **Extreme** Travel and Activity Restrictions shall be enforced throughout all the unincorporated areas of Chelan County, including those unincorporated areas within a Chelan County Fire District. A list of area and road designations are identified in Exhibit A. Per Chelan County Code Chapter 7.52, as of 00:01 a.m. on August 2, 2018, travel and activity restrictions shall be as follows:

1. Travel Restrictions

Extreme restrictions include:

- (i) No operation of any motor vehicles off the roadway.
- (ii) Restricts travel on county roads, except for the following:

- (a) Bona fide residents;
- (b) Landowners and leaseholders to access land to perform work to protect property;
- (c) Authorized and official business only;
- (d) Access to open public lands for legitimate purpose/use;
- (iii) Barricades placed at the intersection of county roads;
 - (a) County roads containing a barricade shall be identified in the list of designated fire hazard areas and restrictions set forth in Exhibit A.

2. Activity Restrictions

Extreme restrictions include:

- (i) No fireworks.
- (ii) No outdoor fires and/or outdoor open flame devices, except as allowed by written permit or approval from the appropriate fire protection agency. Permits are not required for use of the following: (1) commercially made listed/labeled barbeque devices located and used at a residence; and (2) stoves or fireplace fires completely contained within a residence.
- (iii) Use of charcoal briquettes is prohibited, except for commercially made listed/labeled barbeque devices located and used at a residence.

The designation and restrictions set forth above shall remain in effect until the next regular meeting of the Board of Chelan County Commissioners, currently scheduled for August 6, 2018. A list of area and road designations shall be kept in the Chelan County Public Works Department.

EXHIBIT A CHELAN COUNTY DESIGNATED FIRE HAZARD AREAS

All unincorporated areas of Chelan County are designated as **Extreme** fire hazard area.

Extreme Activity and Travel Restrictions, as set forth in Chelan County Code Sections 7.52.030 and 7.52.040, apply throughout <u>all</u> unincorporated areas of Chelan County.
